Competitive dialogue is a form of negotiation that allows for flexibility in cases where other procedures are not likely to lead to satisfactory procurement outcomes. Competitive dialogue has been recognized in the latest European Union directives from 2014 as an opportunity to advance innovation procurement.

Competitive dialogue has existed in Europe and North America for at least one decade, however its application has been restricted. The European Union recently relaxed its procurement directives to allow health care systems to use competitive dialogue and other innovation-friendly processes in more situations. This is quickly fueling various projects that are aiming at extracting greater value from procurement transactions.

This half-day session aims to discuss the value of dialogue with industry before tendering, the benefits of the competitive dialogue process, some examples within health care, and the compatibility of this directive with the legal framework in Canada, particularly in Ontario.
